Ordering in person:

(1) Order at pick up branch : Submit the order to the chosen pick-up Café de Coral branch at least 3 working days (excluding the pick-up day) prior to the food pick up date. At least 5 working days (excluding the pick-up day) prior to the food pick up date for specific products.

(2) Order at non-pick up branch : Submit the order to any Café de Coral branch at least 5 working days (excluding the pick-up day) prior to the food pick up date and specify the branch for pick up.



Personal Information Collection Statement
